### **Recommendation for funds to cover overexpenditures for completed projects financed by other resources\*\***

#### *Summary*

The present report summarizes expenditures in excess of commitments for completed projects financed by other resources for which no additional support has been forthcoming. UNICEF recommends that the Executive Board approve an amount of \$7,137,112 from regular resources to cover these overexpenditures.

#### **A. Background**

1. In 1988 the Executive Board, in its decision 1988/11 H (E/ICEF/1988/13), established the following policy on expenditures in excess of commitments:

The financial implementation of supplementary-funded programmes should remain within the funded amounts. However, during the implementation, because of exchange rate fluctuations or other price increases that are out of UNICEF control, the resource needs may exceed those of the original project budget. In such cases, the donor(s) will be approached for additional support. If the additional support is not forthcoming, the project will be phased out and any overexpenditures will be allocated from general resources. The secretariat will report all such cases to the Executive Board specifying the amount in United States dollars, the assisted country to which it relates, and the explanation of overexpenditures.

2. An analysis of expenditures in excess of commitments, totalling \$7,137,112, by area or country programme, is provided in paragraph 5. Allocation of regular resources by the Executive Board will allow UNICEF to finalize the accounting for other resources for the period to 31 December 2003.

3. Of the total \$7.1 million, \$2.8 million relates to supplementary-funded programmes and \$4.3 million to emergency relief and rehabilitation operations. A total of \$4.4 million is attributable to contributions that have been reduced, cancelled or deemed non-collectible or which have decreased in value between pledge and payment dates, and \$2.7 million is attributable to price increases out of UNICEF control and to other issues.

4. UNICEF is cognizant of its financial management imperative to ensure effective, efficient and economic use of the resources contributed by its donors and has ensured that financial management policy, procedures and, since early 2000, systems minimize the risk that expenditures will be incurred in excess of commitments. In recent years, accountabilities for implementation have been clearly communicated, responsibility for monitoring has been delegated, and financial reporting has been enhanced and made more widely available through the use of technology. UNICEF makes every effort to avoid expending in excess of commitments and approaches donors for additional support when such cases arise as a result of the variable environments in which UNICEF operates. Nevertheless, as noted by the Executive Board, there will always be implementation issues outside of UNICEF control which give rise to overexpenditures. UNICEF will continue actively to seek to minimize these overexpenditures.

## B. Draft decision

5. In accordance with the policy stated in paragraph 1 above, the Executive Board is requested to approve regular resource funding to cover expenditures in excess of commitments, totalling \$7,137,112, for the following programmes:
