## **Annotated provisional agenda**

### **1. Opening of the session: statements by the President of the Executive Board and the Executive Director**

### **2. Adoption of the provisional agenda, timetable and organization of work**

*[For action — E/ICEF/2007/13]*

The provisional agenda has been drafted in consultation with the Bureau. The Executive Board will adopt the agenda for the session, making any amendments it considers necessary.

### **3. Proposals for UNICEF programme cooperation**

*[For action]*

#### **(a) Approval of country documents discussed at the annual session of 2007**

At the annual session of 2007, the Executive Board discussed 18 draft CPDs for full country programmes (Bhutan, Bolivia, Cameroon, Comoros, Cuba, Djibouti, Eastern Caribbean multi-country programme, Guinea-Bissau, India, Jordan, Malawi, Maldives, Malaysia, Mali, Papua New Guinea, Sierra Leone, Sri Lanka and Palestinian children in Jordan, Lebanon, the Occupied Palestinian Territory and the Syrian Arab Republic). The comments made were shared with the respective country offices and the CPDs were revised as appropriate and posted on the UNICEF website within six weeks after the session. The Executive Board will approve these CPDs on a no-objection basis unless at least five members have informed the secretariat in writing that they wish to discuss a particular country programme.

#### **(b) Draft country programme documents (CPDs)**

*[For action]*

At this session, the Executive Board will consider a total of 17 CPDs, plus one subregional recommendation for other resources. There are 14 draft CPDs for full programme cycles. These are presented to the Board for discussion and comment, and for approval of the aggregate totals of estimated regular and other resources in the programme budget. Taking into account the comments made at this session, the draft documents will be revised and posted on the UNICEF Internet site within six weeks after the session. They will be submitted to the Board for approval on a no-objection basis at the first regular session of 2008 unless at least five members have informed the secretariat in writing, within six weeks of the posting of a document, of their wish to bring a particular country programme before the Executive Board.

The 14 draft CPDs for full country programmes are broken down as follows:

(a) Four from Eastern and Southern Africa: Lesotho, Madagascar, Rwanda and Somalia (E/ICEF/2007/P/L.36, E/ICEF/2007/P/L.37, E/ICEF/2007/P/L.38 and E/ICEF/2007/P/L.39);

(b) Four from West and Central Africa: Democratic Republic of the Congo, Equatorial Guinea, Liberia and Togo (E/ICEF/2007/P/L.41, E/ICEF/2007/P/L.6, E/ICEF/2007/P/L.42 and E/ICEF/2007/P/L.43);

(c) Four from the Americas and the Caribbean: Colombia, Costa Rica, Mexico and Nicaragua (E/ICEF/2007/P/L.44, E/ICEF/2007/P/L.45, E/ICEF/2007/P/L.46 and E/ICEF/2007/P/L.47);

(d) One from East Asia and the Pacific: Pacific island multi-country programme (E/ICEF/2007/P/L.51);

(e) One from South Asia: Nepal (E/ICEF/2007/P/L.52);

In addition, three short-duration CPDs for one-year programmes are presented to the Board for approval at this session. These short-duration programmes are usually prepared so that the UNICEF programme cycle may be harmonized with the cycles of other agencies, or to allow time for finalization of the UNDAF. It is expected that the full country programmes will be presented to the Executive Board in 2008. The CPDs are as below:

(a) One from Eastern and Southern Africa: Botswana (E/ICEF/2007/P/L.40);

(b) Two from the Americas and the Caribbean: Haiti and Venezuela (E/ICEF/2007/P/L.50 and E/ICEF/2007/P/L.48).

There is also a recommendation for other resources funding for a subregional programme for the Americas and the Caribbean region (E/ICEF/2007/P/L.49).

**(c) Overexpenditure**

The Board will have before it a recommendation covering overexpenditure for country programmes (E/ICEF/2007/P/L.53).

**4. Summaries of midterm review and major evaluations of country programmes**

*[For information]*

Prepared in response to Executive Board decision 1995/8 E/ICEF/1995/9/Rev.1), these reports specify, inter alia, the results achieved, lessons learned and the need for any adjustments in the country programmes. The Board is to comment on the reports and provide guidance to the secretariat, if necessary. The reports cover Eastern and Southern Africa (E/ICEF/2007/P/L.29); West and Central Africa (E/ICEF/2007/P/L.30); the Americas and Caribbean (E/ICEF/2007/P/L.31); East Asia and the Pacific (E/ICEF/2007/P/L.32); South Asia (E/ICEF/2007/P/L.33); Central and Eastern Europe and the Commonwealth of Independent States (E/ICEF/2007/P/L.34); and the Middle East and North Africa (E/ICEF/2007/P/L.35).

**5. Organizational review of UNICEF**

This report has been prepared in response to Executive Board decision 2007/7, in which the Board requested the Executive Director to submit a report at this session which includes: details of the proposed organizational review, including the impact on the UNICEF presence in the field at the country and regional levels and the time frames envisaged for the implementation of the proposed changes; the rationale for each of the proposed changes; a clear explanation of the implications on the biennial support budget for 2008-2009 of the implementation of changes as a result of the review; and a summary of the areas where proposed reforms are still being considered.

**6. Results-based budgeting: preliminary draft of the biennial support budget**

This informal background document will respond to the Executive Board's request, made at the annual session of 2007, for a preliminary draft biennial support budget, based on information available, in the results-based format.

**7. Medium-term strategic plan: planned financial estimates for 2007-2010**

By its decision 2000/3 (E/ICEF/2000/8/Rev.1), the Executive Board changed the medium-term strategic plan (MTSP) from a four-year rolling plan, updated every two years, to a four-year fixed plan. A medium-term financial plan is presented with the MTSP. The estimates on which the financial plan is based are reviewed and revised annually. This report contains the planned financial estimates for the period 2007-2010, which provide a basis for determining the level of regular resources programme submissions for approval in 2008. It is presented to the Executive Board for approval.

**8. Implementation of Executive Board decision 2007/4 on crisis management and business continuity capacity**

This report, presented in response to Executive Board decision 2007/4, discusses information including the coordination and sharing of resources with other United Nations entities and the identification of a suitable data-centre site.

This report is presented annually to the Executive Board for review and comment.

**10. Status report on implementation of Executive Board decision 2007/3 on the recommendations of the Board of Auditors**

This report will respond to Executive Board decision 2007/3, in which the Board requested a report including: an overview of the strategic implications of the recommendations of the Board of Auditors for the management and strategy of UNICEF, such as the implications of the significant increase in total year-end unexpended funds, the rising levels of other resources contributions and the development of common services; and an update on the implementation of the main recommendations. The report will also provide information on the UNICEF response to all outstanding recommendations of the Board of Auditors.
