Both of those committees, which were not established until 1961, were abolished as part of the implementation of General Assembly resolution 48/162, through decision 1994/R.1.1 (E/ICEF/1994/34/Rev.1).

¹⁰ In 1992, the Executive Board decided that, effective 1 August 1993, in the election of the Chairman, there would be due regard for equitable geographic rotation among the five regional groups (decision 1992/7, E/ICEF/1992/14). Until then, the chairmanship had alternated each year between industrialized and developing countries, as had the chairmanship of the two committees.
