


Getting familiar with the Executive Board

- ☐ The Executive Board is the governing body of UNICEF since its creation by the General Assembly in 1946.
- UNICEF reports annually through the Executive Board to the Economic and Social Council, which in turn reports to the General Assembly.
- ☐ The annual term runs from 1 January to 31 December. Each year, the Economic and Social Council elects members of the Board from among the United Nations Member States or members of the specialized agencies.
- ☐ The Executive Board provides intergovernmental support to the programmes of UNICEF and oversight to the organization, in accordance with the overall policy guidance of the United Nations General Assembly and the Economic and Social Council.

Getting familiar with the Executive Board

The Bureau (President and 4 regional Vice-Presidents) serves as a bridge between the UNICEF secretariat and the regional groups. Members of the Bureau normally coordinate informal consultations within their respective regional groups. ☐ The Bureau usually meets monthly; during the three yearly sessions of the Executive Board, the Bureau meets daily. Can schedule ad-hoc meetings as needed throughout the year. The Executive Board of UNICEF works in close cooperation with the Executive Boards of UNDP/UNFPA/UNOPS and UN Women. The President also maintains contact with the Presidents of the Executive Boards of the other funds and programmes with regard to joint meetings and related issues.
