### Extensions of ongoing country programmes

#### Note by the secretariat

#### *Summary*

In accordance with Executive Board decision 2009/11, this note informs the Executive Board of the two-month extensions of the country programmes for Azerbaijan and Uruguay, approved by the Executive Director.

The note further presents the reasons for the proposed two-month extensions of the country programmes for Argentina and Iraq, following one-year extensions; and the proposed two-month extension for the Syrian Arab Republic, following four consecutive one-year extensions. The Executive Board is requested to approve these programme extensions. The new country programme documents (CPDs) are expected to be submitted at the 2016 first regular session.

#### *Draft decision*

##### *The Executive Board*

1. *Takes note* of the two-month extensions of the country programmes for Azerbaijan and Uruguay, which were approved by the Executive Director, as presented in table 1.

2. *Approves* the two-month extensions of the country programmes for Argentina and Iraq, following one-year extensions; and a two-month extension of the country programme for the Syrian Arab Republic, following four consecutive one-year extensions, as presented in table 2. This approval will allow programme continuity until the consideration, at the 2016 first regular session, of the new country programmes.
