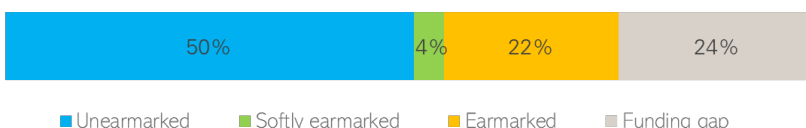


UKRAINE AND REFUGEE OUTFLOW

As of 27 June, UNICEF has received **US\$ 717.7million** for the response out of which 50 per cent is unearmarked against the HAC. UNICEF's HAC funding requirement has been revised to **US\$ 949 million**. UNICEF is immensely grateful for the timely and quality financial support from public and private sector partners so far. The flexible and timely funding will continue to play an important role in this response as it enables UNICEF and partners to act rapidly and strategically to meet the growing needs and fulfill the rights of children and their families affected by this crisis. UNICEF is fully committed to transparency and accurate financial reporting standards, and regular updates can be found in the Ukraine crisis situation reports and on the Financial Tracking System (FTS) managed by OCHA.
